I. CALL TO ORDER

Mr. Tibbs called the meeting to order at 10:01 a.m.

II. APPROVAL OF AGENDA

Mr. Tibbs solicited a motion to approve the agenda. Mr. Tibbs requested a closed session under Section 2.2-3711(A)(7) Consultation with legal counsel and briefings by staff members or consultants pertaining to actual litigation to be added to the agenda as agenda item 7B after FY24 Budget. Mr. Lawrence also requested a discussion on opportunities to spend some of the localities' opiate settlement funds to offset the localities' shares. Mr. Tibbs made this addition 7A. A motion was made by Mr. DeHaven to approve the agenda with the additions. Mr. Wells seconded the motion. The Authority unanimously approved.

III. APPROVAL OF THE MINUTES FROM NOVEMBER 3, 2022

Mr. Tibbs solicited a motion to approve the minutes from the November 3, 2022, meeting. A motion was made by Ms. Koszanecki to approve the minutes. The motion was seconded by Sheriff Falls. The Authority unanimously approved.

IV. EMPLOYEE OF THE QUARTER

The Authority recognized Kathy Ritenour as the Jail's Fall 2022 Employee of the Quarter.

V. ELECTION OF OFFICERS

Mr. Wells made a motion to nominate Mr. Tibbs as Chairman, Ms. Kozanecki seconded the motion. The motion was unanimously approved.

Mr. Hoffman nominated Deputy City Manager John Piper as Vice-Chairman. Sheriff Falls seconded the motion. The motion was unanimously approved.

Ms. Kozanecki nominated Superintendent Corbin as Secretary/Treasurer. Mr. Wells seconded the motion. The Jail Authority unanimously approved.

VI. FY23 BUDGET UPDATE

Superintendent Corbin reported the fund balance on February 14, 2023, as \$4,068,370. Our current revenues are estimated at \$575k over what is budgeted; this is due mostly to the Comp Board revenue not being finalized until June 2022, which included a 5% increase and an adjustment in all base salaries. He also reported the expenditures is estimated to be about \$2.4M savings (\$1.6M of that is due to personnel savings with an average of 30 vacancies); other savings due to contract nurses not being

used and Anthem/Pharmacy costs have stabilized/decreased. The Superintendent reported that for the past 2 years we spent \$750,000, in the past 7 months we have paid \$78,000, which an anomaly. He is still leery whether it will stay that way. The Superintendent anticipates our beginning fund balance in FY24 will be \$7M. These are only estimates based off the information we have through February.

VII. FY24 BUDGET UPDATE

Superintendent Corbin presented the following chart:

^{*}The budget proposed in November included a 2% COLA and a \$600,000 fund balance draw. A 7% COLA and a \$818,000 fund balance draw is now proposed for FY24.

- Frederick County included a 7% COLA in their budget overview. This increases the budget by \$818,001.
- Compensation Board estimates are higher than what was presented by \$300k. This will be added into revenues, reducing locality shares.

Superintendent Corbin reported that the fund balance as of February 16, 2023, was \$4,068,370. Anticipated beginning fund balance FY24 to be \$7M.

Excess = \$1.7M can be used towards FY25 budget

VIIA. LOCALITIES' OPIATE SETTLEMENT FUNDS

The Jail Authority had a brief discussion on how the Opiate settlement funds could be used with the possibility of using the funds to offset localities' shares or expand the mental health program. The boundaries need to be very clearly stated.
