# I. CALL TO ORDER

Chairman Tibbs called the meeting to order at 10:02 a.m.

#### II. APPROVAL OF AGENDA

Chairman Tibbs solicited a motion to approve the agenda. A motion was made by Sheriff Millholland to approve the agenda. Mr. Wells seconded the motion. The Authority unanimously approved.

#### III. APPROVAL OF THE MINUTES FROM NOVEMBER 2, 2023

Chairman Tibbs solicited a motion to approve the minutes from the February 22, 2024, meeting. Sheriff Sumption noticed a mistake on page 3 under FY25 Locality Shares for Clarke County, the amount should have been \$480,518. A motion was made by Mr. Wells to approve the minutes with the correction. The motion was seconded by Sheriff Millholland. The Authority unanimously approved.

Superintendent Corbin reported the anticipated return to Fund Balance:

Revenues:

\$30,109,978

Expenditures:

-\$27,618,246\*

\$ 2,491,732

Current Fund Balance = \$4,994,410 + \$2,491,732 = \$7,486,142 \$7,486,142 - \$1,500,000 (FY25 draw) = \$5,986,142

12% of FY25 budget = \$3,429,483

#### VII. FY25 BUDGET UPDATE

Superintendent Corbin reported the changes to the FY25 budget from the February meeting:

- > COLA went down from 4.5% to 4% savings of \$85,775
- ➤ Comp Board revenue estimates up by \$504,972

The Superintendent reported that the Comp Board gave a 3% salary increase which will help offset the 4% COLA. The Jurisdictions shares are \$590,000 less than what you saw in February.

#### VIII. PAY GRADE CHANGES

Superintendent Corbin requested that he be allowed to create a new SAP grade for the NRADC Administrative Assistant position which is currently a grade 211 to a 213. This position is a unique position in terms of responsibility and overall job description, which includes hiring process, grievance process, Personnel Action Forms, data sheets, accountability for uniforms/equipment, evaluations, promotions, resignations, HR liaison, etc. This position is currently held by Ms. Wilson, who has been with Frederick County for 42 years, and has reached the top of her range and as long as she remains employed with Frederick County, she will never receive the full salary increase. This year, she would only receive a 2% increase and not the full 4% COLA. When Ms. Wilson does decide to retire, this will

also help attract someone who can perform the same duties, which are unique to the position that Ms. Wilson currently holds.

A motion was made by Ms. McCann-Slaughter to approve the new SAP grade. Sheriff Millholland seconded the motion. The Jail Authority unanimously approved.

There was a short discussion regarding the job title, and it was recommended to change the title to Assistant to the Superintendent. Ms. McCann-Slaughter recommended the title change and Sheriff Millholland seconded the motion. The Jail Authority unanimously approved.

The second position that Superintendent Corbin wanted to discuss was the Certified Medical Assistant position. Superintendent Corbin requested a change to this position's current pay grade 204 (\$33,275 to \$54,844) to pay grade 209 (\$42,469 to \$69,997). We would hire someone to fill this position instead of an LPN. The CMA can do the same duties as an LPN except for medical screens and doctor call.

A motion was made by Ms. McCann-Slaughter to approve the new pay grade for the Certified Medical Assistant. Sheriff Millholland seconded the motion. The Jail Authority unanimously approved.

## IX. NRADC APPROVAL MATRIX

Superintendent Corbin provided the Jail Authority with an Approval Structure. After a brief discussion, the Jail Authority wanted "in a 12-month period" to be added to the section titled Personnel Committee Approvals with regards to salary increases less than 10% and/or less than \$25,000. Also, the Jail Authority would like the Personnel Committee to review the Superintendent's job description and make the Jail Authority aware of any changes that are made. After the Approval Matrix has been amended, the Jail Authority would like it to be presented to them at the next Jail Authority meeting.

## X. CCC PROGRAMS UPDATE

Superintendent Corbin introduced Captain Cottrill, who oversees the operation of the Community Corrections Center. Captain Cottrill provided the Jail Authority with a Community Corrections Programs update.

#### XI. ADJOURN

As there was no further business brought before the Authority, the meeting adjourned at 10:55 a.m.
